Dear Members of the Chapman Townhomes, Inc.:

We are the attorneys for your Association. The Association's membership voted on whether to approve and adopt a First Amended and Restated Declaration of Covenants, Conditions, Restrictions and Easements ("Restated CC&Rs"). Passage required approval of at least 75% of the member voting rights (50 out of 66 members). Despite the Association's significant efforts to increase voter participation, only 46 members participated in the process, with 38 votes cast in favor, falling short of that necessary.

California law permits the Association to file a petition requesting the Court to authorize the Restated CC&Rs. At the request of your Board of Directors, we filed this Petition, which the Court will consider at a hearing on the date and time set forth above. You may support, oppose or refrain from participating in this proceeding. You may file papers in opposition but you must adhere to the timelines and procedures described in the attached Order.

The Order also indicates that copies of the Petition and all related documents and exhibits in connection with this hearing will be posted by the Association on a website maintained by this office. These documents may be accessed as follows:
